


TRUCK REPORT

Truck 86 assisted La Quinta firefighters with a technical rescue at Desert Express Carwash where a worker was walking behind a car when her foot got caught in the car wash pulley. The employee's foot was wedged between the pulley chain, the metal support beams and the carriage that moves the vehicle down the conveyor. The specialized/ technical equipment used off of Truck 86 were the Grip Hoist, Air Tools, Cribbing and Hardware Bags. Truck 86 assisted with water rescues throughout La Quinta during the September 8th flooding. Out of that incident they realized their dry suits were heat damaged and deteriorating and needed replacing. They were able to purchase 9 new dry suits and are ready for the next water rescue incidents. Truck 86 also assisted in structure fires and a drowing in the City of La Quinta.

SIGNIFICANT EVENTS

July 31, 2014 14:51 Technical Rescue, Avenida Juarez

A Time Warner employee was working on a service pole approximately 20 feet above ground. The employee became ill with heat related symptoms and fire crews had to rescue the patient from the pole. The patient was transported to a local hospital by AMR.

August 7, 2014 00:54 Structure Fire, Avenida Carranza

Fire Units responded to a reported structure fire and found a single story residential dwelling with light smoke coming from the front of the house. The fire was contained to the interior living space with slight fire involvement into the attic space. An adult woman was alerted to the fire by a smoke detector and had self-evacuated from the residence. No injuries were reported.

August 26, 2014 21:34 17:03 Structure Fire, Avenida Herrera

Fire Units responded to a reported garage fire. Engine 32, first engine on scene reported heavy smoke and fire from the garage. The fire had spread through the entire attic and interior of the home. The fire was contained within 30 minutes. Two pet cats perished in the fire and a pet turtle survived. Red Cross responded and assisted with the two adult female occupants that were left displaced. The fire is under investigation.

September 4, 2014 09:16 Technical Rescue, Washington

Fire Units responded with Truck 86 to a traumatic injury at the Desert Express Car Wash. An employee who was walking behind a car had her foot wedged between the car wash pulley chain, the metal support beams and the carriage that moves the vehicle down the conveyor. Units extricated the patient's foot within 20 minutes and the patient was transported to a local hospital.

September 8, 2014 08:00 Flooding, City of La Quinta

La Quinta units, Truck 86, Truck 33 as well as multiple fire units from surrounding cities and county areas responded into the City of La Quinta to assist in area flooding. Multiple rescues, traffic collisions and residential flooding were mitigated during the downpoor and the hours after the storm passed.



September 12, 2014 19:22 Multi Casualty Incident, Avenida Alvarado

Fire Units responded to five patients in a residence feeling ill with multiple symptoms. A Carbon Monoxide detector had been activating. A Hazmat response was ordered along with AMR ambulance's. Hazmat could not detect any chemicals in the area. All five patients were transported to area hospitals.

September 14, 2014 11:24 Structure Fire, Dune Palms Rd.

Fire Units responded to a two alarm commercial fire at the vacant Sam's Club building in La Quinta. First on scene unit reported smoke and fire from the rear of the building. The fire was contained within an hour to the roof and decking. The fire is under investigation.



September 16, 2014 14:13 Drowning, PGA Golf Course

Fire Units along with the Riverside County Fire Dept. Swift Water Task Force responded with a boat to a drowning at the PGA Golf Course's Nick Private Pond. A worker employed to remove algae and vegetation in the approximately 20' deep pond had fallen in. Other employees and relatives of the victim attempted a rescue before calling 911. The victim became tangled in the vegetation and was unable to be rescued. Because of the unknown location and time under water the Riverside County Sheriff's Dive Team was called and the Fire Department left the scene in the care of RSO.



Administrative Reports

La Quinta's is currently in the hiring process for replacing it's Fire Safety Specialist, a vacancy left open with the promotion of Jason Stubble to the Fire Safety Supervisor (Assistant Fire Marshal).

La Quinta is also currently in the hiring process for a full time Riverside County Fire Dept. Emergency Services Coordinator. This employee will be assigned to La Quinta and will be responsible for the cities Emergency Operation Center (EOC) and Emergency Response Program.

Toughbooks have been ordered to assist paramedic engines in the city of La Quinta. The funds to purchase the Toughbooks are through AMR fine money the city receives annually. They are used primarily for completing the ePCR's (electronic patient care reports). Currently, we write all of the patient's pertinent information on a 3 copy form. Once the information is transferred to AMR, the transporting agency, we take the form back to the fire station. When back at the station, the paramedic transfers the information to a computerized program which sends the information to the hospital and is used for statistics and legal documentation. Using tablets at the incident eliminates the 20 or so minutes it takes to get back at the station per call to enter the information into the computer, and the hospital gets the information quicker. It also stores non confidential information on the patient. If we have been on the patient previously, their address and telephone number comes up, saving time and eliminating the need to reenter information. Medical history, allergies, medicines or other confidential information is not stored. They are currently working with AMR so that the information on scene can be electronically transferred to AMR units via their tablets.




