Quarterly Report for January-March, 2014

Honorable Mayor City Council Citizens of La Quinta

I take this opportunity to discuss recent improvements and strategic goals our department has made over the last quarter. The following pages highlight the effort we've made to improve upon the actual and perceived sense of safety within our community.

The crime statistics on page two indicate the fluxionary increase and decrease in various crime types during the first quarter of 2014, when compared with the first quarter of 2013. The La Quinta Police Department aggressively monitors crime patterns to make adjustment in field deployment, special program operations, and crime intelligence gathering. As your police, we recognize any crime trend increase can be a source of concern to our citizens and we move swiftly to address those concerns. In that vein, the patrol officers and specialized law enforcement teams meet together regularly and share information about problems within the community. As a result of this teamwork, many reported crimes are rapidly solved in our community and the offenders are held accountable for their actions.

Building upon the existing foundation mentioned earlier, the police department is developing crime prevention programs that reach out for mutual support and problem-solving initiatives among our citizens. As one example, the Crime Prevention Unit has implemented a new "Crime Free Multi-Housing" solution among several apartment managers and apartment owners throughout our city. This new program folds into the overall crime reduction strategy by offering crime-fighting tools and partnerships in the city.

We introduced Sergeant Christopher Frederick in January 2014 and we support him as he supervises the city's Traffic Services Team, Crime Prevention Unit, Community Service Officers, and Volunteer Program. Sergeant Frederick brings a wealth of knowledge, tireless energy, and quality leadership traits to our police department. As a La Quinta resident, Sergeant Frederick feels a vested interest in each aspect of solving the problems we face together.

- In January, SET Officers responded to a robbery at 78468 Hwy 111, La Quinta (Del Taco). Officers learned the suspect took money from the cash register and fled the scene in a silver pickup truck toward Bermuda Dunes. Patrol Officers located a silver Nissan pickup truck traveling at a high rate of speed along eastbound Fred Waring Drive and stopped the vehicle. The two occupants were later identified as the robbery suspects. Alfonso Camacho, a 27 year old resident of La Quinta, was identified as the primary suspect. Felicia Ward, a 24 year old resident of Palm Desert, was implicated as the "get away" driver.
- In January, SET Officers conducted a follow up investigation at the Blythe Jail and interviewed Matthew Macdonald, a 33 year old La
 Quinta resident, regarding several Identity theft and fraud cases. Macdonald admitted he committing several frauds and thefts over
 the past several months. Officer McAnallen added charges of identity theft, burglary, and embezzlement to Macdonald's booking
 charges.
- In January, SET conducted a probation compliance check at a home in the 82500 block of Corte Lucia in Indio. The probation search
 was relates to a La Quinta theft that occurred on December 14, 2013. The case agent is Officer Rebecca Smith and this is an ongoing investigation.
- In January, SET served two search warrants in the 84500 block of Avenue 51 in Coachella. The search warrant was related to separate burglaries in La Quinta. Upon the execution of the warrants, evidence related to both cases was recovered at the location. The suspect, Karen Sepulveda, a 24 year old Coachella resident, was arrested for burglary, fraud, and forgery, and booked into the Indio Jail.
- In January, SET were assigned to the Humana Challenge and President Clinton's security detail. They provided unformed security through the event and President Clinton's stay.
- In February, SET Officers conducted a pedestrian check in the Home Depot parking. He arrested Juan Lopez, a(32 year old Desert Hot Springs resident, for possession of methamphetamine and drug paraphernalia. Lopez was booked into the Indio Jail.
- In February, SET Officers conducted a vehicle stop at Jefferson Street and Miles Ave in La Quinta. A probation search of Dennis Dinsmoor, a 30 year old Indio resident, revealed Methamphetamine. He was arrested and booked into the Indio Jail.
- In February, SET Officers conducted a pedestrian check on Calle Sinaloa and Avenida Mendoza, and arrested Dean Linstrom, a 50 year old La Quinta resident, for possession of stolen property.

In January, La Quinta BDU responded to the La Quinta Wal-Mart and contacted the Asset Protection Agent who had a subject detained for theft. BDU arrested the male for shoplifting and booked him into the Indio Jail.

In January, La Quinta BDU Officers assisted La Quinta Patrol in a Robbery investigation at the Del Taco in La Quinta. During the course of the investigation, the suspect vehicle was located in Indio and the suspect was apprehended. BDU worked closely with the Thermal Investigations Unit and La Quinta Patrol to gather evidence and witness statements prior to the male subject being arrested for the robbery and booked into the Indio Jail.

In January, La Quinta BDU assisted the Coachella Community Action Team in serving a weapons related search warrant in the city of Coachella. The warrant stemmed from a large amount of gun fire witnessed at the residence during a New Years Eve celebration. An automatic assault rifle, handguns, and ammunition were recovered from the residence and one suspect was arrested.

In January, La Quinta BDU attended the Resort Communities Security Association (RCSA) meeting at the Desert Falls Country Club where Thermal Station Captain Shouse and Palm Desert Station Captain Vest were guest speakers for the event.

In January, La Quinta BDU assisted La Quinta SET in the service of two search warrants in the city of Coachella. The warrants were related to two separate residential burglaries in La Quinta. Upon the service of the warrants, evidence related to both cases were recovered. The suspect was arrested for burglary, fraud, and forgery, and booked into the Indio Jail.

In January, La Quinta BDU conducted a pedestrian check in the La Quinta Cove and contacted a female subject who had three misdemeanor warrants for burglary, violation of a court order and trespassing. The subject was also found to have a syringe on her person. She was booked at the Indio Jail for possession of drug paraphernalia and warrants.

In January, La Quinta BDU responded to the La Quinta Wal-Mart regarding a subject Asset Protection Agents had detained for theft. BDU Officers arrested the female subject for shoplifting and she was booked her into the Indio Jail.

In January, La Quinta BDU conducted a pedestrian check on the east side of the La Quinta Wal-Mart and contacted a male subject. The subject was found to have an active warrant for DUI that involved injuries. The male was arrested and booked into the Indio Jail.

In January, La Quinta BDU participated in the Humana Challenge Golf Tournament at PGA West and La Quinta Country Club. BDU and SET provided security during the duration of the event.

In January, La Quinta BDU and SET served a property related search in the city of Coachella. The search warrant was related to a vehicle theft reported in La Quinta. During the service of the warrant, the suspect was already in custody for the vehicle theft. The search warrant yielded evidence against the suspect for the theft.

In January, La Quinta BDU and SET served an arrest warrant and search warrant in the city of Palm Desert. The warrants were related to an assault with a deadly weapon at the Beer Hunter in La Quinta. Officers arrested the suspect for assault with a deadly weapon, and he was booked into the Indio Jail.

In February, La Quinta BDU worked in partnership with La Quinta SET while serving an arrest warrant in La Quinta. The subject was on probation for possession of stolen property in addition to having an active felony warrant for burglary. Officers arrested a male subject for felony warrant for possession of stolen property. A probation search was also conducted at his residence.

In February, La Quinta BDU worked in cooperation with La Quinta SET and La Quinta Patrol while investigating a burglary at the La Quinta Wal-Mart. The suspect fled out of the business with stolen property after Asset Protection attempted to detain him. Officers located the suspect in the area and detained him. The suspect was arrested for commercial burglary and booked into the Indio Jail.

In February, La Quinta BDU responded to the La Quinta Wal-Mart to collect evidence on a previous investigation and was notified a theft was in progress. BDU Officers responded to the garden exit of the business and contacted the suspect as he exited the store. The male was found to have numerous stolen items on his person. He was arrested and booked in to the Indio Jail for commercial burglary.

In February, La Quinta BDU responded to a theft in progress call at Wal-Mart. The suspect fled the location after Asset Protection attempted to detain him. BDU Officers located the subject on Adams Street and Blackhawk Lane, however, the suspect again fled northwest through a residential area. Officer eventually located the suspect near the dog park near Miles Avenue. Upon further investigation, the suspect had arrived at Wal-Mart on a stolen bicycle which had been stolen from the La Quinta Wal-Mart the previous day. The suspect was arrested on two counts of commercial burglary, possession of stolen property, resisting arrest, and violation of probation and booked into the Indio Jail.

La Quinta BDU assisted the Coachella Valley Narcotics Task Force in serving a narcotics related search warrant in the city of La Quinta. BDU was assigned to detained the suspect outside of her residence as she arrived home in her vehicle.

Significant Activity for January, February and March 2014 (Continued)

In February, La Quinta BDU worked in partnership with La Quinta Patrol who authored a search warrant for a residence in Palm Springs. The warrant stemmed from burglaries at multiple Target stores in the valley, to include La Quinta's Target. The warrant was served successfully, however the suspect was not home at the time of the service. Criminal charges have been filed with the District Attorney's Office.

In February, La Quinta BDU authored a surveillance program in response to the recent backflow water valve thefts in the commercial district along Hwy. 111 in La Quinta. BDU and SET conducted surveillance along the business corridor and deployed surveillance cameras during the graveyard hours. No thefts occurred and no arrests were made during the operation.

In February, La Quinta BDU assisted La Quinta SET serve a property related search warrant in the La Quinta Cove. During the service, stolen property from several burglaries in the La Quinta Cove were covered. SET authored the search warrant and will conducting follow-up investigation regarding the recovered stolen property. The primary suspect was not present during the service of the warrant, however, he was arrested the following day and booked in the Indio Juvenile Hall.

In February, La Quinta BDU responded a robbery that occurred in the La Quinta Cove. Patrol Officers responded and contacted the victims. The victims reported that three suspects had approached them as they were walking in the cove and robbed them at gunpoint for their phones and money. BDU Officers located a occupied vehicle parked in the nearby area of the robbery scene. BDU Officers contacted and detained the occupants, as they matched the descriptions of the suspects in the robbery. Both victims identified two of the juvenile occupants of the vehicle as the suspects. Both suspects were arrested, interviewed, and booked into the Indio Juvenile Hall for robbery.

In March, La Quinta BDU authored a search warrant based on the above mentioned robbery in the La Quinta Cove. La Quinta SET assisted with the service of the search warrant. The search warrant was in regards to the third outstanding suspect from the robbery. BDU Officers arrested a male juvenile and located stolen property from the robbery and a 9mm handgun used in the robbery. The juvenile was arrested and booked into the Indio Juvenile Hall for robbery and being a minor in possession of a firearm.

In March, La Quinta BDU responded to a man down call at the La Quinta Home Depot. Upon arrival, the reporting party identified a male walking from the location. BDU officers contacted the male subject who was found to be in possession of heroin and heroin paraphernalia. In addition to the illegal narcotics, the male suspect had an active felony burglary warrant and two misdemeanor warrants. Upon being booked at the Indio Jail, jail staff located an additional .2 grams of heroin hidden in the suspects underwear.

In March, La Quinta BDU conducted a meeting with La Quinta businesses who have Loss Prevention Agents and Asset Protection Agents staffed in their businesses. During the meeting, BDU provided training and information regarding legal issues, procedures, current trends and report writing. BDU Officers, Loss Prevention and Asset Protection agents shared information regarding problem customers, exchanged contact information, and created a network between the businesses. BDU strives to improve the relationship between LP and AP entities in effort to better serve the La Quinta business community.

In March, La Quinta BDU worked in cooperation with La Quinta Patrol while responding to a theft at the La Quinta Kohl's. The suspect fled from the location and was eventually located by La Quinta Patrol. BDU Officers responded and assumed the investigation. The suspect was arrested and booked into the Indio Jail for commercial burglary, theft with prison priors, and violation of probation.

In March, La Quinta BDU developed a program with Alcohol Beverage Control. The goal of the program was to help identify any businesses who may be selling alcohol to minors in the city of La Quinta. The program included twenty-four businesses in the city who were considered "off sale" facilities. Off-sale facilities allow alcohol to be purchased and taken from the location. La Quinta BDU Officers, La Quinta SET Officers and an ABC Agent worked together to safely conduct the operation. At the conclusion of the operation, one of the twenty-four businesses were found to be in violation of selling alcohol to a minor.

In March, La Quinta BDU worked in partnership with Palm Desert SET to monitor a subject known to steal metal backflow water valves. The subject is a focus in several backflow valve thefts and thefts of gasoline from vehicles in La Quinta, Palm Desert and Indio. La Quinta BDU, La Quinta SET, and Palm Desert SET conducted surveillance on the subject and his vehicle. After witnessing the subject steal gasoline in Thousand Palms, he was taken into custody in the city of Coachella. The subject was arrested, interview and booked into the Indio Jail. Additional follow-up investigations were conducted, connecting him to several metal backflow valve thefts in La Quinta.

In March, La Quinta BDU held a business meeting at the La Quinta Red Robin Restaurant. Prior to the meeting, BDU Officers personally visited each business (approximately 350 retail businesses) in La Quinta and invited them to the meeting. During the meeting, BDU Officers discussed the role of the Business District Unit, current crime trends occurring in the area, crime statistics for their particular shopping plaza, and educated them in Robbery Prevention and Robbery Response.

In February, the Traffic Services Team participated in the Office of Traffic Safety DUI saturation patrol campaign for DUI enforcement on Super Bowl Sunday.


In March, the Traffic Services Team participated in the Office of Traffic Safety DUI saturation patrol campaign for DUI enforcement on Saint Patrick's Day.





In February, SRO Klicka attended the Riverside County Sheriff's Department Bicycle Patrol Class and obtained a Bicycle Patrol Certificate.



In March, SRO Klicka investigated an incident at La Quinta Middle School and initiated a "Kids with Guns protocol". The student was suspended from school and his house was searched. No weapons were located.

In January, SRO Trueblood arrested a male juvenile at La Quinta High School for petty theft and for possession of a knife on school grounds. He was released to parents with charges filed out of custody.

In January, SRO Trueblood investigated reported threats of violence against co-workers at the Desert Sands Unified School District Transportation Department. A 49 year-old Hispanic male bus driver had reportedly made statements indicating he would come to work and shoot co-workers. It was determined that no crime had occurred however statements had been made that alarmed fellow co-workers. The incident was documented and handled within DSUSD.

In January, SRO Trueblood conducted a traffic stop at the intersection of Jefferson and Avenue 50. The driver who was on his way to work at Stuft Pizza in La Quinta was found to be unlicensed and had an outstanding felony no-bail immigration warrant and hold. He was turned over to federal agents at the scene for the outstanding warrant.

In January, SRO Trueblood responded to a reported suspicious vehicle in the vicinity of Ocotillo and Los Manos. The vehicle had left by the time he arrived however; he located the vehicle in the parking lot of Summit High School. A search of the vehicle yielded narcotics, paraphernalia and four knives. The juvenile suspects stated they had been the neighborhood before school using marijuana. They were released to parents at the scene with charges filed out of custody.

In January, SRO Trueblood arrested two male juveniles near the Aliso Development walkway leading into La Quinta Park. The two males were smoking cigarettes while truant from school. Both juveniles fled on foot at which time he chased them on foot catching them on Desert Stream Drive. Both juveniles were issued truancy citations and booked into the Indio Juvenile Hall for resisting arrest.

In January, SRO Trueblood conducted a follow up investigation to a commercial burglary that occurred at the Circle K convenience store located on Calle Tampico. He reviewed surveillance video and identified the suspect as a well documented juvenile repeat offender that resides in La Quinta. he drove to the suspect's residence and placed him in custody then transported him to Indio Juvenile Hall where he was booked into custody for 459 PC.

In March, SRO Trueblood conducted an investigation into reports that a 12 year-old male juvenile had brought a handgun to La Quinta Middle School. I conducted numerous interviews and found that the juvenile had brought an Airsoft pistol to school on two prior occasions. A home search was conducted and the Airsoft pistols were recovered. The incident was documented in accordance with Riverside County Kids With Guns Protocol.
