



**COMMUNITY SERVICES COMMISSION

CALL TO ORDER

A regular meeting of the La Quinta Community Services Commission was called to order at 5:31 p.m. by Commissioner Engel.

CONSENT CALENDAR

1. APPROVE MINUTES OF DECEMBER 8, 2014

Motion – A motion was made and seconded by Commissioners Johnson/Blakeley to approve the December 8, 2014 Community Services Commission Minutes as submitted. Motion passed unanimously.

Commissioner Johnson voiced concern that the sculptures were not original artwork (copies of previous work) and no proposals were received from local artists.

Motion carried 3 to 1, with Commissioners Engel, Blakeley and Simonds voting YES, Commissioner Johnson voting NO.

2. CONSIDERATION OF TWO COMMISSIONERS TO ASSIST THE CIVIC CENTER ART PURCHASE COMMITTEE

Deputy Hylton presented the staff report.

Motion – A motion was made and seconded by Commissioners Blakeley/Johnson to appoint Commissioners Simonds and Engel to assist the Civic Center Art Purchase Committee in selecting Civic Center Art during the La Quinta Arts Festival. Motion passed unanimously.

3. PARTICIPATION FOR THE CITY BIRTHDAY PARTY AND COMMUNITY PICNIC

Deputy Hylton presented the staff report.

Motion – A motion was made and seconded by Commissioners Simonds/Blakeley to have all Commissioners work at the City booth for the City Birthday Party and Community Picnic. Motion passed unanimously.
