Executive Order #4 - Golf course closure

I am the president of Tradition Golf Club and am writing to urge you to reconsider the requirements set forth in Executive Order #4. Like most private clubs in La Quinta, we have instituted strict measures to minimize the chances for close interaction among members and staff and have taken extraordinary measures to avoid the possible transmission of the coronavirus as a result of touching various surfaces.

Some of the specific steps we have taken include:

- Member/spouse only play. No guests including extended family members.
- One player per cart.
- No club cleaning by staff. Members must retrieve their own water bottles.
- 4. Raised cups to eliminate the need to reach into the cup to retrieve golf balls.
- 5. No club events or any gatherings of members.

The reality is that playing a round of golf at Tradition is safer than many of the activities that are allowed on the Governor's order. Golf is an important to the physical and mental well-being of our members.

We urge you to reconsider your position on golf course closures.

Good afternoon, I am writing to express my concern over the golf course closures that were ordered yesterday. Our course had implemented multiple regulations to ensure the safety of staff and members. Everyone has adhered to the regulations, essentially eliminating any common touch points possible and still allowing people to be outside for a few hours and gaining the health benefits- mental, physical and emotional benefits. The virus is not airborne and it does not survive well in sunshine or open spaces. Having people stay inside, especially people that have extended family households is going to provide a much more hospitable environment to any virus and the ruling essentially eliminates our opportunity to be in our own backyards. Everyone here has the highest respect for and adherence to our community, city and state rules and are seeking reconsideration of this ruling. We are not allowing any guests on property, anyone with any symptoms no matter how mild have self isolated, golf course adaptations such as no flagsticks, pvc pipe in the hole to prevent people reaching in and golfers using their own cart or walking and carrying their own equipment have been instituted to prevent common touch points. As a nurse practitioner with a background in infectious disease I have read all of the CDC and scientific information I have available and believe golf offers people tremendous benefit and is one of the lowest infection risks in our community. The City's emergency executive order #4 closing down all private golf courses within the La Quinta City limits is excessive and a draconian response to the Coronavirus CIV-19 threat. Additionally, I question its legality.

At our private club the club facilities have been closed. Golf course personnel, other than maintenance personnel, are no longer on site. The locker rooms, driving range, staging station are all shut down.

What we have implemented is a level of "social distancing" that is entirely appropriate and a well thought out solution to continued golf play.

Members can play in their own carts, or use push carts, each providing their own water, etc. Members ride individually and do not pair up to play. There is no close contact between members. There is no touching of other members golf equipment, cart, golf balls, etc. Green flags do not allow golf balls to drop more than 1/2 the diameter of the golf ball into the cup. We are not allowed to touch the green flags. Rakes have been removed from all bunkers. The "social distancing" and separation that we have achieved is no different than a walk down our country clubs streets with friends, something that has not yet been banned.

I am 73 years old and have been a successful business man. I spent most of my business career as an insurance broker working with public entities. For example, I handled the insurance for over 40 years for the City of Beverly Hills amongst many other municipal and school clients. I would like to weigh in regarding the order to close La Quinta golf courses. Our course (Andalusia) has been operating on a skeleton crew basis.

The club is allowing the course to be without maintenance for most of the week. I've been playing golf with no contact from other members. Everyone is keeping their distance, using their own golf carts, removing rakes from traps and leaving the flags alone. At the moment, there is no opportunity to touch anything on the golf course.

The club has taken extraordinary measures to eliminate items that could get someone sick. The normal staff has been sent home, with only the needed staff available to manage the club and serve take out food.

Denying people the ability to be outdoors and escape the current crisis makes no sense and defies logic. Everyone is maintaining social distancing and respects the boundaries of others.

I would respectfully ask that the City modify the order and set guidelines that any club could follow to remain open. Our club has fewer than 250 members. The Canadian population has already returned home. It appears as if very few members are using the club, making the order even more oppressive to the few people who want to exercise and be outdoors.

Please consider the overall value we receive from playing golf during a highly stressful time. It would be prudent to establish solid rules that are verifiable, rather than cut off our ability to exercise and be outside in a safe, healthy manner. If we follow the rules of distancing, which is the primary restriction in place throughout the country, the chance of spreading the virus seems next to impossible.

### Good afternoon.

By way of introduction I am a physician and surgeon. We have had a home in The Hideaway for more than 10 years and we are members at The Hideaway and The Quarry. My wife and I are avid golfers and appreciate the physical, mental, and emotional benefits of that recreation. We support and practice hand washing, social distancing, and other personal behaviors to limit covid-19 transmission.

Closure of golf courses makes little sense from a disease containment standpoint. I am unaware of data indicating that golf courses pose a greater risk of covid-19, or other viral disease transmission, than parks, hiking, boating and fishing, camping, and other outdoor recreation. Going to the grocery store, pharmacy, or any other "essential" indoor community space has more risk of covid-19 transmission. The specific closure of golf courses seems somewhat prejudicial.

I have been impressed by the thoughtful measures that management at both clubs have taken to protect their employees and members. Let the managers and the golfers decide if the risk is acceptable. As a healthcare professional and a golfer, it's my opinion that the aggregate benefits of keeping the courses open outweigh the risks for the private clubs in La Quinta. Thank you.

Dear Mr. McMillen,

The City's emergency executive order #4 closing down all private golf courses within the La Quinta City limits is excessive and a draconian response to the Coronavirus CIV-19 threat. Additionally, I question its legality.

At our private club the club facilities have been closed. Golf course personnel, other than maintenance personnel, are no longer on site. The locker rooms, driving range, staging station are all shut down.

What we have implemented is a level of "social distancing" that is entirely appropriate and a well thought out solution to continued golf play.

Members can play in their own carts, or use push carts, each providing their own water, etc. Members ride individually and do not pair up to play. There is no close contact between members. There is no touching of other members golf equipment, cart, golf balls, etc. Green flags do not allow golf balls to drop more than 1/2 the diameter of the golf ball into the cup. We are not allowed to touch the green flags. Rakes have been removed from all bunkers. The "social distancing" and separation that we have achieved is no different than a walk down our country clubs streets with friends, something that has not yet been banned.

I am 73 years old and have been a successful business man. I spent most of my business career as an insurance broker working with public entities. For example, I handled the insurance for over 40 years for the City of Beverly Hills amongst many other municipal and school clients. Additionally, I handled the insurance for Sunrise Colony (Indian Ridge and Toscana) for many years. I understand risk and the handling of risk.

I am more exposed to the Virus by going to the market in order to procure groceries or to the gas station to purchase gas. In both cases, I take previously unprecedented steps to protect myself and those around me.

I do not take this lightly, but hope that the "cure" does not become worse than the "disease", both for our economy and our way of life, but it is, and has to be, a balance. At our country club, we have no knowledge of anyone who has become infected with the Virus. We are self policing and self quarantining. Golf is one of the only remaining outdoor activities left to us. Please modify your executive order so as not to create any conflict between us.

I am writing as the CEO of Andalusia Country Club in La Quinta.

We greatly appreciate all of the time and energy the City has been putting into managing and adjusting during this COVID 19 crisis for the benefit of all of the people of La Quinta and beyond.

With regards to the recent order to close all golf courses, I would respectfully request that you consider some of the information below which you might not be awere of:

- Andalsuia Country Club, like many others in La Quinta offers its usually operates members numerous facilities
  including multiple restaurants, fitness and spa centers, numerous clubhouse activities and golf courses. All of
  these facilities and activities are now closed. Until today, consistent with the Riverside Environmental
  Department decision, our golf course was being operated under strict guidelines which address the potential
  areas for the potential spread of the virus including:
  - a. Members only, no guests. No family members, except spouses.
  - b. Very limited staff and no caddies. Most of the staff will still remain working even under closure of the course as it is necessary to maintain the same minimum maintenance and oversight to preserve the assets from long term damage.
  - c. Only private golf carts, no club carts being used.
  - d. Golf shop, driving range and member lounges are closed.
  - e. Members are maintaining required social spacing of at least six feet (which is not difficult to do on a golf course). No gatherings of 10 people or more anywhere on the course.
  - f. No rakes in sand traps, no seed dispensers or towels and raised cups on the greens to eliminate the areas where multiple members could be touching things on the golf course.

The Governor's statement made it clear that the "shelter in place" mandate does not mean people cannot go outside for fresh air and exercise. He said people could walk their dogs, as an outdoor example.

We are each confident that our golf course operations are a positive contribution to the fight against the COVID-19 virus and they provide members a much needed opportunity to unwind and get outside in an appropriate manner that conforms with federal and state orders and guidelines. This also helps take pressure and density of contact away from alternative public venues which are seeing too many people already, like the local hiking trails and public parks and open spaces.

I underdstand that the situation at the many public golf courses in La Quinta are much different and it may be much more difficult to expect that the appropriate rules and procedures will be carried out. In a close knit private club like Andalusia our management knows who is playing golf, and the manner in which they conduct themselves. This is a much more regulated and socially distanced outdoor activity than walking your dog, meeting other dog walkers, and congregating while the dogs play together or going for a hike or going to the park.

We respectfully request that the City of La Quinta considers a detailed policy of operating criteria under which they can be confident that the limited used of the private golf courses can be safely continued. Indian Wells continue its current

I am sure the City considered many things when drafting Executive Order #4 and I appreciate, as I am sure all the residents of this fine city do, the thought that went into the Order.

Perhaps safety of our employees was uppermost in the minds of those drafting the order. I can assure you that LaQuinta Country Club has a legacy of care for employees and has always worked to provide a safe and fulfilling environment for all of our many employees, from greens keepers to wait staff to administrative/managerial staff. This care for employees was a critical piece of the decision to exclude the possibility of any interaction between employees and members who may be using the course to walk (or ride) as an individual and to play a round of golf. That is why we have closed the pro shop and ceased all golf related services.

The Club also cares deeply about its members, many of whom live on the course and use it, not only for golf, but for taking early-morning or late-day walks in our park-like setting. Now more than ever, we believe it is important to allow members to utilize the golf course. We have put in place stringent protocols for the use of the course, including no guests, only single players and absolutely no interaction closer than 6 feet and, most often, a much greater distance than that. We believe this activity is critical to our members' emotional well-being and overall health. Isolation is known to be a significant detriment to the health of seniors.

Of course, in drafting the Order, you could not have known about all of the important and lifesaving protocols we had already put in place. I hope this will cause you to pause, reconsider, and allow LaQuinta Country Club to reopen its course to members.

I am the President of our Board of Directors and I assure you that our board is singularly focused on maintaining the safety of our staff and our members during this rapidly spreading virus. Each decision we have reached is first and foremost centered on ensuring our decision is keeping everyone as free as possible from contracting this terrible virus. We have taken numerous steps to ensure the safety of our wonderful staff. The building that stores member carts has been closed and all attendants have been furloughed for their safety.

We have taken several additional steps to eliminate the spread of the virus. I am writing to voice my concern for your recent order to close all golf courses in La Quinta. To the extent this order makes sense for golf courses that allow general public access I do not understand how closing private golf courses falls in the same category.

I live at Andalusia and we have already instituted reasonable rules such as no guests are allowed on the course, removal of flags on greens and rakes in bunkers, closure of practice facilities and only private carts allowed and individual carts are encouraged to promote social distancing between non cohabiting members. We, like other similar private communities with golf courses, have instituted rules to encourage some level of social activity during these very trying times while also adhering to generally accepted social distancing considerations. Management had already decided to not allow outside guests in the community to play golf so as a community we are different in composition than other public or semi-private courses that allow outside players on their course or property.

I ask that you reconsider your rule to close all golf courses and allow private, self contained courses like Andalusia, to remain open to members only. I am the golf course superintendent at La Quinta CC. During the last week, and especially today, I have received many questions from my employees asking me why did they close the course, and more importantly, do we still have a job.

La Quinta CC has implemented many new practices to keep our employees safe from the Covid-19 virus. We have staggered our start times so no more than 8 employees are at the maintenance shop at one time. We have been supplying our staff with gloves and hand sanitizer. We have masks available if they want to wear one for their own peace of mind. We have implemented a comprehensive cleaning program for the lunchroom, bathrooms and the equipment. We are cleaning inside the building 3 times per day. We are cleaning all equipment even morning before it goes out. We are stressing the 6' apart requirement. Our operation has never been safer.

On the golf course we have removed all rakes, ball washers, trash cans and anything else that multiple people could come in contact with. We are requiring single riders in all carts.

The thing that is hurting my employees more than anything is not knowing if they will have a job in the future. Any the city can do to help the golf course stay a viable business will help my employees and my members.

I'm worried that a long term closure of our course will cause us to lose members and jeopardize the financial future of La Quinta CC and all its employees.

Please know that I am committed to keeping my employees safe. (I have a written Covid-19 mitigation plan that we began implementing last week.)

I'm also asking the City to keep the financial well being of them and their families in mind when they consider how long the golf course will be closed. The length of this closure could determine the future of La Quinta CC and their jobs.

Dear Mr. McMillen,

The City's emergency executive order #4 closing down all private golf courses within the La Quinta City limits is excessive and a draconian response to the Coronavirus CIV-19 threat. Additionally, I question its legality.

At our private club the club facilities have been closed. Golf course personnel, other than maintenance personnel, are no longer on site. The locker rooms, driving range, staging station are all shut down.

What we have implemented is a level of "social distancing" that is entirely appropriate and a well thought out solution to continued golf play.

Members can play in their own carts, or use push carts, each providing their own water, etc. Members ride individually and do not pair up to play. There is no close contact between members. There is no touching of other members golf equipment, cart, golf balls, etc. Green flags do not allow golf balls to drop more than 1/2 the diameter of the golf ball into the cup. We are not allowed to touch the green flags. Rakes have been removed from all bunkers. The "social distancing" and separation that we have achieved is no different than a walk down our country clubs streets with friends, something that has not yet been banned.

I am 73 years old and have been a successful business man. I spent most of my business career as an insurance broker working with public entities. For example, I handled the insurance for over 40 years for the City of Beverly Hills amongst many other municipal and school clients. Additionally, I handled the insurance for Sunrise Colony (Indian Ridge and Toscana) for many years. I understand risk and the handling of risk.

I am more exposed to the Virus by going to the market in order to procure groceries or to the gas station to purchase gas. In both cases, I take previously unprecedented steps to protect myself and those around me.

I do not take this lightly, but hope that the "cure" does not become worse than the "disease", both for our economy and our way of life, but it is, and has to be, a balance. At our country club, we have no knowledge of anyone who has become infected with the Virus. We are self policing and self quarantining. Golf is one of the only remaining outdoor activities left to us. Please modify your executive order so as not to create any conflict between us.

This keeps the homeowners inside the gates, and keeps some of our staff working, while practicing safe protocols.

The golf courses in many communities around our valley can be considered a "park" within the community. If that park-like environment can be utilized for the mental and physical well-being of the community residents, it will contribute to their ability to stay well, be strong and healthy. This is not about playing golf for golf's sake, it is to utilize a significant asset within our many communities to promote health and wellness. We at Hideaway have revised our golf play protocols to remove our employees from any contact with members and member carts. We have also revised policies to include reducing the number of players at any given time, eliminating congregating by the closure of practice facilities, and other protocols that I am prepared to review with the City Health Officers.

I appreciate your consideration to allowing restricted golf play on the cities golf courses to promote mental and physical wellbeing for our homeowners and citizens during this very stressful time.
