## **Sustainability Update**

### The 2022 FOOD WASTE Recycling Program and YOU!

Organic waste that decomposes in a landfill releases a significant amount of greenhouse gas emissions that potentially contributes to global climate change.

By composting organic waste, instead of sending it to landfills, we can close the loop on sustainability while creating a nutrient-rich soil amendment that's ready for use in farms and gardens.

#### Senate Bill 1383

The California Senate passed a bill requiring a 75% reduction in organic waste disposal by 2025. All residences and commercial businesses will be required to participate in this program to recycle organic waste, including food waste.

Residents can expect an organics program rollout in late fall. Residents will receive notice prior to implementation.

#### **METAL**

- Aluminum Cans
- Tin Cans

#### **GLASS**

- Bottles
- Jars

#### **PLASTIC**

- Bottles
- Containers

#### **PAPER**

- Cardboard
- Paper



## **Household Hazardous Waste (HHW) Disposal**

**Household Hazardous Waste (HHW) Collection Facility:** 

Palm Springs Permanent HHW Collection Facility 1100 Vella Road, Palm Springs

Non-Holiday weekend Saturdays only

October - May: 9:00 a.m. to 2:00 p.m. June - September: 7:00 a.m. to 12:00 p.m.

## The following are acceptable Household Hazardous Waste items:



- Antifreeze
- Batteries
- E-Waste
- Fertilizers
- Fluorescent Tubes
- · Fluorescent Tubes
- Household Cleaners
- Medications
- Needles (in Sharps Containers)
- Old Gasoline
- Paints
- · Pesticides & Herbicides
- Pool Chemicals
- Propane Tanks
- Used Motor Oil

It is illegal to transport more than 15 gallons or 125 pounds of HHW per trip. Multiple trips are acceptable if storage capacity and facility staffing allows.

## **Free Document Shredding Events**

To help La Quinta residents dispose of sensitive documents safely and securely, the City and Burrtec offer two free document shredding events per year. Individuals are allowed a maximum of four (4) banker-boxes of documents. These services are free for La Quinta residents. *Note:* Proof of residency is required and a maximum of four (4) banker-size boxes per vehicle will be accepted.
