HOUSING COMMISSION MINUTES WEDNESDAY, MARCH 9, 2022

CALL TO ORDER

A regular quarterly meeting of the La Quinta Housing Commission (Commission) was called to order at 4:06 p.m. by Chairperson Gaeta-Mejia.

This meeting provided teleconferencing accessibility pursuant to Executive Orders N-60-20 and N-08-21 executed by the Governor of California, and subsequently Assembly Bill 361 (AB 361, 2021), enacted in response to the state of emergency relating to novel coronavirus disease 2019 (COVID-19) and enabling teleconferencing accommodations by suspending or waiving specified provisions in the Ralph M. Brown Act (Government Code § 54950 et seq.).

STAFF REPORT

AGENDA TITLE: APPROVE FUNDING OPTION FOR GALILEE CENTER FOR FISCAL YEAR 2022/2023

RECOMMENDATION

Recommend to the Housing Authority a funding option to provide assistance to Galilee Center for Fiscal Year 2022/2023.

EXECUTIVE SUMMARY

- Galilee Center (Galilee) requested \$5,000 in funding from the Community Services Grants Program for Fiscal Year 2021/2022 and was recommended \$1,500 to be awarded by the Community Services Grant Review Committee.
- City Council approved the recommendation during the October 5, 2021, City Council Meeting, noting that services provided by Galilee may coincide with Housing and Homeless Prevention, warranting the Housing Commission's review.
- Galilee has requested the Housing Commission (Commission) and Housing Authority (Authority) consider an ongoing allocation of \$5,000 annually to support the center.
- Galilee provided the Commission and staff a tour of Galilee, located in Mecca.

FISCAL IMPACT

The Low-Mod Housing Authority fund has a current budget of \$250,000 for FY 2022-23 available in account number 243-0000-60532. If approved, a budget adjustment would increase funding to \$255,000.

BACKGROUND/ANALYSIS

Galilee has requested funding from the City of La Quinta previously, applying for the Community Services Grant Program and receiving \$1,000 in the 2018/19 program, and \$1,500 from the 2021/22 program. Staff recommended approval of these grants as they assisted in relieving the impacts of COVID-19 and food availability for those in need in the area. During the October 5, 2021, City Council meeting, a discussion of services provided by Galilee that may be related to

housing activities supported by the La Quinta Housing Commission and Authority were brought up by presenters of their services, resulting in direction by City Council for staff to bring to the Commission for their review and guidance.

During a Study Session held during the Commission's Regular Meeting on March 9, direction was provided to coordinate a tour of Galilee. Commission and staff attended a tour on April 6, led by Co-Founder Claudia Castorena. The tour provided education on the history of how the center came to fruition, and services provided such as: shelter, food, medical care, clothing, utility, and rental financial assistance, and emergency relief services for children and seniors. Details were provided regarding facility operations of living quarters, showers, dining hall(s), and the kitchen. To provide opportunity for locals experiencing hardship, Galilee also has a store open to the public for everyday purchases and vouchers to those that qualify for clothing, kitchenware, school supplies, diapers, baby formula, furniture, and toiletries.

Staff has reviewed the request for assistance of annual funding to Galilee for \$5,000 in funds to Galilee for Utility/Rental financial assistance and Shelter support and recommends approval as these services are acceptable expenditures for the Low-Mod Housing Authority fund, supporting Housing Assistance and Homeless Prevention.
