On behalf of Visit Greater Palm Springs, we fully support the extension of the City's Ironman contract for two years.

As you know, Visit Greater Palm Springs (Visit GPS) is working diligently to ensure that our tourism economy rebounds to normal and continues on a healthy and sustainable path into the future. Tourism in Greater Palm Springs was severely impacted by COVID-19 and the recovery will take a long time to reach sustainable levels. Ensuring the return of the Ironman event is critical for our local economy. The event will also send a positive message that our region is open and ready for visitors.

The Ironman event held December 8, 2019, attracted 2,400 racers plus 5,000 event attendees, creating a lodging demand of approximately 8,902 room nights. The visitors generated \$6.4 million in direct business sales with a regional impact of \$9.9 million, resulting in local tax revenue of over \$340,000. This data comes from a Tourism Economics analysis of the event in 2019.
